Deputy Director General for DG Employment, Social Affairs & Inclusion, European Commission

Zoltán Kazatsay is a Deputy Director-General of DG EMPL (Directorate-General for Employment, Social Affairs and Inclusion) in the European Commission. As of 1 December 2011 he coordinates the management of the European Social Fund. He joined the European Commission in 2004 coordinating transport activities. As of 1997 as Deputy Secretary of State in Hungarian Ministry of Transport he was in charge of transport policy issues and the

accession negotiations with the EU in the transport sector. He graduated from the Technical University of Budapest as a civil engineer.

Thomas Fischer

Head, Department of Political Strategy and Planning, DGB

Thomas Fischer heads the Department of Political Strategy and Planning with the German Trade Union Confederation (DGB). He started with the Gütersloh-based foundation in 2000 where he led several project teams on issues like the EU's future Constitution, the reform of Germany's federal system, modern governance in OECD countries. Prior to joining the foundation Thomas was Managing Director of the European Center for Research on Federalism at the University of Tuebingen from 1998 to 2000. Thomas studied political sciences, law and economics in Munich, where he received a Master's degree from Ludwig Maximilian University. After working as a research assistant at the Geschwister Scholl Institute for Political Sciences he joined the research team of the project "Organising a Federal Structure for Europe" also located at the University of Munich in 1995. His main fields of expertise are European Governance, the social dimension of the EU and comparative federalism.

Director-General, DG Education and Culture

Martine Reicherts has been appointed as the new head of the European Commission's (EC) Directorate-General Education and Culture (DG EAC), which is the executive branch of the European Union responsible for policy on education, culture, youth, languages, and sport. The DG EAC also supports projects and programmes such as Creative Europe and Erasmus+. Born in Luxembourg and trained as a lawyer, Reicherts takes over from Xavier Prats Monné as part

of a reshuffle of the European Commission's senior management. Prior to her appointment at DG EAC, she was the Director-General for the Commission's Luxembourg-based Publications Office (DG OP) since August 2007.

Andriana Sukova-Tosheva

Director, Social Market Economy in Member States I: ESF, DG Employment, Social Affairs & Inclusion

Mrs. Andriana Sukova-Tosheva is an economist by education. In the past 20 years she has worked with big national and international teams, being part of governmental and NGO national and international institutions. In August 2010 she was appointed Director in DG EMPL. He studied Physics at the University of Valencia and obtained his PhD from the University of Barcelona. He subsequently served as a postdoctoral researcher at CERN, Geneva, and was a professor of theoretical physics at the Universities of Valencia and Barcelona. Rolf Tarrach is the former president of CSIC Madrid (the Spanish Scientific Research Council) and a former member of the European Union Research Advisory Board, of the European Heads of Research Council group which he also chaired and of the 5-year assessment panel of experts of the European Commission. Professor Tarrach continues

to be a professor of Physics at the University of Luxembourg. He has been a Council Member of the European University Association (EUA) for ten years.

Commissioner for Digital Economy and Society

Günther H. Oettinger is European Commissioner for Digital Economy and Society since 1st November 2014. On 10 February 2010 he became European Commissioner for Energy and from 1st July – 31st October 2014, he was Vice-president of the European Commission. From 2005-2010, he was Prime Minister of Baden-Württemberg (Germany) and, since 1984, a member of the regional Parliament ("Landtag"). He was the leader of the CDU Landtag group from January 1991 to April 2005.

A lawyer by training, Günther H. Oettinger became actively involved in politics during his adolescence. He is a member of the Federal Executive Committee and of the Steering Committee of the CDU Deutschlands.

Nicolas Schmit,

Minister of Labour, Employment and the Social and Solidarity Economy, Luxembourg
